Vendors must be broken down by 7pm. Each vendor is to provide their own tables, chairs, canopy/tent. Vendors are provided with a 10'x10' vendor space and must not exceed allotted space, including canopy/tent legs.** Vendors are reminded to keep all their goods/merchandise above ground, to protect them from damage in the case of street water or rain. The Festival is not responsible for any losses, broken or damaged goods/merchandise.

**RESTRICTIONS:** The sale of live animals such as pets, goldfish, birds, etc. is not permitted. The sale of “Silly String” or similar products are prohibited for sale by the City Ordinance.
