**SET UP INSTRUCTIONS:** Street fair will be located on Manila Ave. btw First St. & Sixth St., Jersey City, NJ. Sign in at Registration Booth located adjacent the main stage (Second St. & Manila Ave.). Space locations will be assigned on a first come, first serve basis if you have not pre-paid. **Registration begins at 8am. Vendor’s vehicle off-loading must be complete by 9am to make way for the “5K Race/1 Mile Fun Walk.” Each vendor is to provide their own tables and chairs. 10’x 10’ tent/canopy is permitted (no fee). You will be charged per 10’ x 10’ space.** Inquire at Registration Booth for free parking.

**RESTRICTIONS:** The sale of live animals such as pets, goldfish, birds, etc. is not permitted. The sale of “Silly String” or similar products are prohibited for sale by the City Ordinance. Pre-prepared or packaged food items such pastries, cookies, ice cream, cold food, snacks, soda, water, etc., are permitted. Sale of alcoholic beverages is not permitted. All contents of bottled drinks must be served in plastic/paper/styrofoam cups. Cold food vendors are strictly prohibited to have open flames.
